ORDINANCE NO. 96 - 01

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF AMERICAN CANYON REVISING RAW WATER QUANTITY CHARGES

WHEREAS, the City of American Canyon has adopted ordinances establishing water quantity charges and water connection charges; and

WHEREAS, the existing raw water rates were established based upon incomplete information, and did not include any administrative charges; and

WHEREAS, this matter was properly noticed for a public hearing, set for the regular City Council meeting of April 18, 1996, and continued to May 16, 1996;

NOW, THEREFORE, the City Council of the City of American Canyon does ordain as follows:

SECTION 1: The City hereby repeals and replaces the Raw Water Quantity Charges set forth in Ordinance No. 95-13, section 5, with the revised Raw Water Quantity Charges as set forth below:

W. 100 WATER QUANTITY CHARGE - Inside the City and Outside the City Service.

(a) Each customer inside the City shall pay:

(1) <u>Residential</u> - Each residential customer shall pay an Inside-the-City Water Quantity charge calculated at the rates set forth in Table 1 of this Ordinance for the designated fiscal years per 100 cubic feet for water consumed during each billing period.

(2) <u>Commercial</u> - Each commercial customer shall pay an Inside-the-City Water Quantity Charge calculated at the rates set forth in Table 1 of this Ordinance for the designated fiscal years per 100 cubic feet for water consumed during each billing period.

(3) <u>Raw Water</u> - (Reserved) Each raw water customer shall pay an Inside-the-City Water Quantity Charge of \$0.75 per 100 cubic feet for water consumer during each billing period, as set forth in Table 1 of this Ordinance.

(4) <u>Large Industrial</u> - Each large industrial customer shall pay an Insidethe-City Water Quantity Charge calculated at the rates set forth in Table 1 of this Ordinance for the designated fiscal years per 100 cubic feet for water consumed during each billing period.

Ordinance 96 - 01 Water Service Charges, Relating to Raw Water

(b) Each customer outside the City shall pay:

(1) Residential - Each residential customer shall pay an Outside-the-City Water Quantity charge calculated at the rates set forth in Table 1 of this Ordinance for the designated fiscal years per 100 cubic feet for water consumed during each billing period.

(2) Commercial - Each commercial customer shall pay an Outside-the-City Water Quantity Charge calculated at the rates set forth in Table 1 of this Ordinance for the designated fiscal years per 100 cubic feet for water consumed during each billing period.

(3) Raw Water - Each raw water customer shall pay an Outside-the-City Water Quantity Charge of \$0.32 \$0.75 per 100 cubic feet for water consumer during each billing period, as set forth in Table 1 of this Ordinance.

(4) Large Industrial - Not applicable at this time.

SECTION 2: The provisions of this Ordinance replace and supersede any inconsistent provisions contained in prior ordinances of the District or City establishing Water Quantity Charges.

SECTION 3: This ordinance shall take effect and be enforced and in effect on July 20, 1996 until June 30, 1999. The Ordinance shall be noticed a reasonable time before June 30, 1999. so as to allow for its possible extension.

The foregoing Ordinance was introduced and read at a regular meeting of the City Council of American Canyon, held on the 19th day of September, 1996.
