ORDINANCE NO. 96-04

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF AMERICAN CANYON DELAYING WATER RATE INCREASES FOR SIX MONTHS

- WHEREAS, the City of American Canyon has adopted ordinances establishing water quantity charges; and
- WHEREAS, Ordinance 95-13 revised the City's water rates and established an annual rate increase to be effective on July 1 of each year, until July 1, 1998; and
- WHEREAS, the City's recent Water Service Agreement with the City of Vallejo affords the City an opportunity to improve its operating efficiency and effectiveness; and
- WHEREAS, implementing rate increases should be done during the winter, when usage is low, rather than during the summer, when usage is high;
- NOW, THEREFORE, The City Council of the City of American Canyon does ordain as follows:
- **SECTION 1:** Table 1 of Ordinance 95-13 is hereby repealed and replaced with the revised Table 1, as attached to this Ordinance and made a part thereof by reference.
- **SECTION 2:** That the intent of this Ordinance is to make the water rate increases established under Ordinance 95-13 to be effective on January 1 of each fiscal year, and not July 1.
- **SECTION 3:** The provisions of this Ordinance replace and supersede any inconsistent provisions contained in prior ordinances of the American Canyon County Water District or City establishing Water Quantity Charges.
- **SECTION 4:** This ordinance shall take effect and be enforced and in effect on September 5, 1996.
